# **MEDIATION AND ALTERNATIVE DISPUTE RESOLUTION**



## Mediation

Mediation is a well-established form of dispute resolution. A properly managed mediation process will be guided by an experienced and neutral mediator, selected by the parties to the dispute. This can often result in a solution that makes commercial sense and preserves the relationship between the Parties. Mediation can also often be conducted much faster than conventional dispute resolution proceedings, which saves the cost and time of protracted litigation or arbitration proceedings.

Mediation is aimed at establishing a safe and constructive environment for the parties to critically analyse the issues in dispute with the purpose of facilitating an agreed resolution to that dispute, a resolution from which both parties ultimately benefit. The process is also non-binding unless a settlement is reached. These elements to mediation allow for the exchange of information, thoughts and views with the mediator without a party jeopardising their legal or commercial position if the mediation is not successful and litigation or arbitration ensues.

Parties are free to agree and apply an appropriate set of mediation rules to add structure and clarity to the process. Many African dispute resolution centres such as the Arbitration Foundation of Southern Africa and the Nairobi Centre for International Arbitration (NCIA), already publish their own mediation rules. There may be greater promotion and revision of such rules in the future as mediation becomes better known and possibly more attractive to parties.

Obtaining a compromise or agreement that is acceptable to both parties relies on the participants having trust in the process, which is facilitated by the skill and acumen of the mediator who guides the parties in finding a resolution.

The parties' legal advisors are encouraged to assist the parties during the process to facilitate the viability and terms of settlement reached.

In many jurisdictions, including South Africa, courts are increasingly encouraging adverse parties to consider voluntary mediation. In some jurisdictions mediation has become mandatory and parties will have to prove that they have attempted mediation before they can proceed to trial. The aim is to reduce burdens on the court and to allow for the expeditious and cost-effective resolution of disputes which could benefit from mediation.



## Alternative Dispute Resolution

In addition to mediation, there are other mechanisms available for the alternative resolution of disputes without recourse to formal litigation or arbitration proceedings. These include:

- Formal negotiations between senior representatives of the adverse parties.
- Expert negotiation or adjudication where an expert third party with specialised knowledge in the field related to the dispute makes a decision.
- Conciliation whereby a conciliator plays an active and directive role to facilitate agreement, such as advising on appropriate settlement terms.

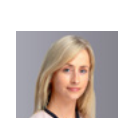

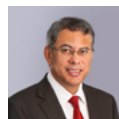
